What is VEVO?

Temporary visa holders often face complex and restrictive conditions that affect their ability to work, study, and remain in Australia. Breaching these conditions, even unintentionally, can lead to visa cancellation or future visa issues.

VEVO (Visa Entitlement Verification Online) is a free service from the Department of Home Affairs.

It helps you **check your visa status and conditions**, including your right to work, anytime, anywhere.

Why use VEVO?



Know your work rights



Avoid visa breaches



Share your visa status with trusted organisations

You'll need:

- Details from your **passport, ImmiCard**, or travel document.
- One of these **identifiers** from your visa grant:

Student Visa (Subclass 500)

Conditions:

8105, 8202, 8533

Limitation:

- Max 48 hrs/fortnight work while studying (unless Masters/Doctoral student)
- Must maintain full-time enrolment
- Must notify education provider of address changes within 7 days

Family of Student Visa Holder

Condition: 8104

Limitation:

- Cannot work before student starts course
- Max 48 hrs/fortnight (unless Masters/Doctoral student)

PALM Scheme Worker

Condition: 8611

Limitation:

- Can only work for PALM sponsor or endorsed sponsor
- Cannot work for themselves

Skills in Demand Visa (Subclass 482)

Condition: 8107

Limitation:

- Cannot stop working for sponsor, change occupation, or work for self for more than: **180** consecutive days **365** total days

Working Holiday Maker (Subclass 417 & 462)

Conditions:
8547, 8548

Limitation:

- Max 6 months with one employer
- Cannot study for more than 4 months

Skilled Regional Visa (Subclass 491)

Conditions:
8539, 8578, 8579

Limitation:

- Must live/work/study in designated regional areas
- Must notify Home Affairs of changes to contact/employment details within 14 days

Visitor Visa (Subclass 600)

Conditions:
8503, 8531, 8609

Limitation:

- No further visa after entry (8503)

No Work Condition: 8101

Condition 8101 is a strict 'no work' rule that prevents visa holders on certain visas from doing any activity that is normally paid work, even if unpaid. Access VEVO to see if this applies to you.
